

## Terms and Conditions for the conserving water colouring competition

- The conserving water colouring competition is being run by Watercare Services Limited (**Watercare**).
- The conserving water colouring competition involves downloading the colouring sheet from [waterforlife.org.nz/kids-stuff](http://waterforlife.org.nz/kids-stuff), printing it out, colouring in it and sending it to [competition@water.co.nz](mailto:competition@water.co.nz) with your name, age and email address (**Competition**).
- The Competition will commence at 9am on Thursday 1 July 2021 and closes at 5pm on Saturday 31 July 2021 (**Entry Period**). No further entries will be permitted after this date.
- To be eligible to win a prize in the Competition, entrants must:
  - be 12 years old or under and living in Auckland.
  - obtain a parent or guardian's permission before entering the competition.
  - provide their name, age, parent or guardian's name and the parent or guardian's email address.
  - submit a coloured in and completed version of the conserving water colouring sheet provided by Watercare.
- All eligible entries will go in to draw and will be chosen at random.
- There are three prizes available for the following age group categories:
  - **Prize for 3–5-year-old category:** one winner from this category will win a Learning Resources Primary Science Lab Set which includes 22 science tools (RRP \$48.90)
  - **Prize 6–7-year-old category:** one winner from this category will win a Galt Science Lab kit which includes 20 fun experiments (RRP: \$45.00)
  - **Prize for 8–12-year-old category:** one winner from this category will win a 4M STEAM Powered Kids Kitchen Science kit which includes 30 interesting experiments using everyday objects and a detailed instruction booklet (RRP: \$39.99)

- Employees or agencies of Watercare or their family members, or anyone else connected with the Competition are not eligible to win prizes.

- Watercare's decision as to those able to take part and selection of winners is final. No correspondence relating to the Competition will be entered in to.
- Information on criteria for this Competition forms part of these Terms and Conditions. Completion of the entry requirements for the Competition shall be deemed acceptance of these Terms and Conditions.
- The winners will be notified by email within one week after the winner is drawn in August 2021 and must provide their delivery address to claim their prize.
- If a winner does not respond to Watercare within 5 working days of being notified by Watercare, then the winner's prize will be forfeited and Watercare shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 5 working days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, that winner's prize will be forfeited and Watercare shall be entitled to select another winner.

- Winners will not be offered a cash alternative and prizes cannot be exchanged. Each prize includes the cost of delivery of the prize within Auckland.
- Winners may be required to take part in promotional activity related to the Competition and each winner shall participate in such activity on Watercare's reasonable request.
