

MAJOR PRIZE - WIN A 7x5 SINGLE AXLE TRAILER

CONDITIONS OF ENTRY

1. Information on how to enter, mechanics of entry and the prize form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of Entry.
