



## OFFICIAL RULES FOR 2022 Spring Giveaway Promotion from a2 Milk®

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES (INCLUDING DC).

discretion, determines is not permitted by law to receive a prize. Sponsor is not required to conduct any advertising or public relations associated with a winner.

**PROMOTION PERIOD:** The Promotion starts on May 26, 2022 at 8:00 AM Mountain Standard Time (“MST”) and ends on June 16, 2022 at 11:59 AM MST (“Promotion Period”).

**HOW TO ENTER:** There are two (2) ways to receive entry into this Sweepstakes via the Website (defined below): (a) the initial entry (“Initial Entry”); and (b) bonus entries (each, a “Bonus Entry”). **Regardless of the method(s) used to obtain entry into this Sweepstakes, there is a limit of seventy-five (75) entries per person during the entire Sweepstakes Period.** Please read the “Bonus Entry” section below carefully to see how entries will be distributed.

Upon the successful submission of your email address, you will receive an email with a verification link. You must click the “Verify Your Email” link found within the email to be directed back to your virtual wallet (“Wallet”) found on the Website. After clicking the “Verify Email” button you will receive five (5) entries (“Initial Entries”) into the drawing. **NOTE:** If you do not click the “Verify Email” link found within the email you will not be able to access your Wallet, you will not receive your Initial Entries into the Sweepstakes and you will not be eligible for Bonus Entries.

Entrant's Facebook, or Instagram profile settings must be set to "public" in order to be viewable by the Sponsor for winner determination. If the Entrant's account is not set to "public", the Sponsor may not be able to verify the entry and the Entrant may not be eligible to win. Entrants may not use multiple Facebook, YouTube, or Instagram accounts to enter.

In order to receive all twenty (20) Bonus Entries via this method, Entrant must open the AMOE digital item and click the "Request Entry" button four (4) times to receive twenty (20) entries.
