Traffic

Josh Milston, traffic consultant attended meeting to brief CCC on area of influence and following discussion at past meetings.

- PH advised that the street closure used in some Venues NSW precincts was not feasible, owing to the complexity of the road network. JT noted that closures of multiple streets was not a feasible or cost-effective option. A more practical solution is working with Council and Local areas Traffic Command to manage effectively
- Will Mrongovius (WM) asked whether it could be more like Perth and Brisbane's Suncorp stadium for events day plans. PH agreed to investigate these.
- RHT from Oxford St is still an issue
- Rob Postema (RP) sought clarity on the location of the drop- off zone on Moore Park Rd.
 - Josh Milston (JM) advised that TfNSW had decided on Moore Park west of Oatley Rd for drop-off zone
- WM queried how often slip-lane arrangements for events would be required.
 - JM advised that these arrangements (when cycle lane on Moore Park Road is converted into a drop-off zone) would be in used approx. 25 events/annum.

Further Action

- PH agreed to investigate Suncorp model during events to key street closures to manage illegal parking and congestion
- Head of Security and Precinct for VNSW, Lucinda Cook to attend next meeting to discuss options for precinct access and events
- PH to re-issue accessibility map that shows drop-off points

Presentation at May meeting to address these actions Modification 10 (MOD 10) - Precinct Village Car Park

- CCC to provide an updated response to SS9835 PVC MOD 10 Planning Statement.
- In section 5 Stakeholder Engagement, Table 3, update CCC reference to state:
 - The CCC was briefed on the proposed modification on 27 September 2024. The briefing was high-level, with limited detail, as the modification documentation was not yet complete. The CCC raised no initial objections at that time based on the information presented. The CCC was briefed thoroughly on 7 February 2025. The CCC raised a couple of issues for resolution, the need to ensure that the reconfigured seating terraces are compliant and functional, and that the planting selections consider public safety and seasonal amenity. Otherwise, no major objections were raised.

Presentation by Besic Watpac

Nicholas Papanikolaou (NP) provided updated presentation on Modification 10 - Precinct Village Car Park incorporating issues raised by CCC (Feb 2025):

Landscape drawings

• Section of bleacher stairs indicated height (440mm) and treads are variable. It was suggested that the unpredictable heights and rhythm of the bleacher stair may be a trip hazard.

Action:

• NP agreed to review and regularise the height and treads of bleachers

Accessible parking - 36 spaces provided

- 24 Accessible parking spaces on Level 0 with level access and ramp access to stadium
- 12 Accessible parking spaces on Level 00M
- SD requested communications be provided to Disability communities/user groups on new access arrangements
