

Avant Practice Solutions Anaesthetics Billings+ Services with Avant Members Terms and Conditions

Terms and conditions

These terms and conditions (the **Terms**), as updated from time to time, are intended to govern the Anaesthetics Billings+ Services Offering with Avant Members promotion (the **Promotion**). The promoter of this Promotion for Billings+ is MyPracticeManual Pty Ltd ACN 150 460 129 trading as Avant Practice Solutions™ (**Avant Practice Solutions**). Participation in the Promotion is subject to these Terms.

Overview of the promotion

1. The Promotion is a promotional activity by which Eligible Individuals can receive a 10% discount against Billings+ submissions (the **Promotion Benefit**) by signing up to the Billings+ service as an active Avant Member and act in accordance with these Terms.

Promotion period

2. The Promotion runs from 9:00am AEST, Monday 29 May 2024 to 5pm AEST 28 May 2025 (the **Promotion Period**).

Eligibility criteria

3. The Promotion is only available to individuals that sign up to the Billings+ service as an Anaesthetist with an active Avant Membership, and are not deemed ineligible in accordance with clause 7 below (the **Eligible Individual**).
1. To be eligible for The Promotion, individuals need to be a registered Anaesthetist who is eligible to bill anaesthesia item numbers.
2. To be eligible, the individual must hold a current Professional Indemnity Insurance policy with Avant Insurance Limited (Avant Membership).
3. Existing Billings+ Anaesthetist customers who are an Avant Member are eligible to enter this Promotion.
4. Directors, management and employees of Avant Practice Solutions and its associated entities, and immediate family of existing customers of each of these persons are ineligible to enter this Promotion.

Participation criteria

5. To participate in the Promotion, Eligible Individual must sign up to Billings+ with an active Avant Membership (the **Eligible Entrant**). There is no minimum spend or lock in contract required to receive the Promotion Benefit.
